mall and medium-sized enterprise proprietors intend to formally petition to Prime Minister Sam Matekane, advocating for his support in compelling the Ministry of Trade, Industry, and Business Development to implement regulations safeguarding certain business sectors exclusively for indigenous Basotho.

This after this publication learned that business unions overseeing rights and interests of local traders are growing frustrated over the impasse of the enactment of the Business Licensing and Registration Act 2020, which prohibits foreign nationals to operate Small, Medium and Macro Enterprises (SMMEs) reserved for locals

According to section 34 of the act, a total of 47 businesses are reserved for Basotho and the prescribed activities are: international road freight transport and logistics, road transport and logistics, motor dealer, real estate agency, clearing agent, warehousing activities, retail sale of household fuel, bottled gas and coal, fast food activities without full restaurant services, hairdressing and beauty treatment, repairs and maintenance of motor vehicles and motor cycles, activities of households as employers of domestic personnel, cleaning of motor vehicles, raising of horses, sheep, goats, pigs and poultry.

Selling of livestock and livestock products, tour operator activities, cleaning activities, landscape care and maintenance service activities, photographic activities, retail sale via stalls and market of food beverages and tobacco products, textiles, clothing and footwear, retail sale of cultural and recreation goods in specialised stores, activities of business agents and brokers, articles in specialised stores including, wholesale and retail sale of health—related articles or products.

Other businesses which foreigners cannot venture in according to the act, are retail sale of animal feeds, including animal and crops, medical goods and chemicals, retail of bread and confectionery products, retail sale of motor vehicle parts and accessories, repairs of motor vehicles parts including vehicle tyres and motorcycle parts, retail sale, maintenance and repair of motorcycles and related parts

and accessories and many more.

According to the business unions, foreign nationals are dominating such activities and they allege that the ministry is doing nothing to enforce compliance or shut down such business to make way for indigenous Basotho.

For this reason, they are fighting for their pound of flesh and now more than ever, they are hell-bent to fight for what is rightfully theirs. They have slated next week Wednesday (May 22), to march to Matekane's office to peacefully protest against delays in the regulations implementation.

The business people told this publication during the week that after several talks and meetings with the Trade Ministry for months now, a consensus still remains elusive and are now escalating matters to the premier's office seeking a definitive solution.

The local traders also said they are now aggravated by a statement made by the Ministry on May 1, where the department

said it was revising section 34 of the regulations to scrap off some business sectors from the list before implementation. It said it had reached an agreement with a task team which had been working to ease implementation of the regulations.

"In an endeavour to implement the regulations, the Ministry sought Government policy direction and such policy directed that the Ministry shall not implement the regulations retrospectively, for examples, businesses that have been licensed to operate in the reserved sectors will not be affected by the regulations and thus should continue operating.

This therefore says, to accommodate the directive, the Ministry is left with no alternative but review the regulations.

Furthermore, the government policy directs that the 47 reserved business items be revisited to ensure that it is all encompassing and should also allow possible withdrawal of other business items.

The Ministry in agreement with the task team has started to review the reg-

ulations and will be engaging with the task team for implementation of the new regulations," the Ministry addressed in a statement.

In an interview with the Weekly Observer on Tuesday, the Secretary General of Meat Products Association in Lesotho, Teboho Motshephe, said they are rallying all locally owned SMMEs from different unions to take part in next week's protest. He said they have been patient enough to cooperate but the Ministry is not reciprocating, rather, it is hindering the transition that should have happened in 2023.

"Yes, it is true, we will be petitioning to the Prime Minister next week. This is a regulation it is not just what we are demanding. It was passed by the 10th parliament and the gazette is there which was signed by His Majesty King Letsie III. Now it is like we are fighting and yet we are advocating for something which has been regulated.

The law clearly states that, when the licenses for foreigners have expired, they shall not be renewed and also, those who desire to venture in those reserved sectors should not be given the green light. Why should we fight for something which was clearly regulated?" he said.

Moshephe blasted the government for harbouring foreign traders in such businesses for their own interests. He said the government is failing to level the playing fields to empower local business owners to succeed. For this reason ,they have vowed not to take this decision lying down.

"This is the very same government that kept urging us to venture in to businesses because it cannot employ us all. How are we supposed to create businesses yet the legislature is failing us? This is ridiculous.

This is the very same government we voted for which should be serving for our interests but they are neglecting us either way, they will see how serious we are next week," Motshephe said.

For his part, the Principal Secretary in the Ministry of Trade, Thabo Moleko, told the Weekly Observer yesterday that they are working tirelessly and are still committed to implement the regulations but in a less controversial way.

He said they had initially made progress and an agreement was close but business people row backed after learning that the ministry will not implement the regulations retrospectively which is a clause they perceive controversial and might spark trouble.

"Some acts of the regulation are controversial and that is why we decided to revise of it. What we proposed was that the implementation will no longer be done retrospectively as it stated. This means foreigners who are already in these businesses will not be booted out but rather, those who will be beginning to venture in those businesses will not get licenses.

That is the main reason why were the two parties are at odds. One thing we considered was that, a lot of Baostho who aspire to own such businesses lack the capacity and skills to operate in those sectors and this could result to massive job losses of those who are employed by foreigners. We will try to come the down so that they can see the bigger picture," Moleko said.

Declares war against notorious famo groups

As police minister declares them unlawful

sieng, Maseru while towards end of April, six people, including five from one family were killed in what was believed to be revenge. These gruesome incident occurred at the villages of Liphakoeng and Fobane in the Leribe district.

Violence and crimes associated with Famo groups has recently spiralled out of control much to the nation's fear calling for immediate response from the government and security agencies.

Addressing a rally at Matlakeng constituency in Butha-Buthe district on his capacity as leader of ruling Revolution for Prosperity (RFP), Matekane said these groups are terrorists due to the menace they pose in the nation at large and thus stern action should be taken against them.

"They have declared themselves as our enemies, when they fail to resolve their issues in South Africa, they return to kill each other here in Lesotho leaving the people terrified. If they cant find their friend, they start to harass and kill other family members," he said.

He said the government has taken heed of such and have issued a national gazette denouncing all famo music groups. He said the gazette clearly states that wherever and whenever they may be seen, they are terrorists and the law should take its course.

"These criminals should be arrested, they should be detained for at least 14 days and more and they should be given severe punishments to ease work for the security agencies."

Matekane also warned the security agencies on their alliance with such groups, pleading with them to cut ties with such crews and return to their mandate of protecting the nation.

"You should know if you are a monster that you will rue the day, and therefore, I instruct you to desist from such actions and focus on your primary duty. I call upon the gangsters themselves to stop what they are doing, repent from your actions, stop terrorising the nation. We will no

longer tolerate any nonsense from you and therefore I plead with you to stop," Matekane thundered.

After the prime Minister's powerful address, the Minister of Home Affairs, Local Government and Chieftainship and Police, Lebona Lephema issued a legal notice of No 37, Vol 69 where he declared the famous groups illegal.

"The Minister responsible for local government, Chieftainship, home affairs and police declares the organizations named described below unlawful by reason of being involved in or promoting or encouraging subversive activities," the gazette says.

The condemned groups are; Terene ea Mokata-lirope; Terene ea Chakela; Letlama (Seakhi); Letlama le le Khubelu; Liala Mabatha; Khang Kholo; Sephiri; Phula Bobete; Parachuti; Tonado; Mahanapuso and Terata ea hlaba.

According to the gazette, other organizations whose activities match the definition of the subversive activity are assumed unlawful. These legal provisions empower the police officer to arrest "without warrant a person whom he reasonably suspects to be a person involved in subversive activity".

They claim the provisions of the Criminal Procedure and Evidence Act 1981 that will apply when police arrest suspects through invocation of this gazette.

It further reads, "14(1) If it appears to the Commissioner that there are grounds for suspecting a person to be involved in subversive activity, the Commissioner [of Police] may make an interim custody order for the further temporary detention of that person for a period not exceeding 14 days.

14(3) If a person is detained under an interim custody order and a detention order is not made in respect of that person within 14 days following the date of the interim custody order, that interim order shall cease to have effect and the person detained shall be released unless he is in custody under some other provision of this or any other law or is arrested under this Part or information, other than, or for reasons, other than, those stated under section 17(1) in respect of the interim custody order."

These provisions also empower the Police Minister to appoint advisers on matters concerning the detention and release of persons.

Standard Lesotho Bank and the Basotho Enterprise Development Corporation (BEDCO), aims to provide M1.4 million seed financing to top aspiring five businesses.

In its official launch for the call for proposal that was held at BEDCO premises in Maseru on Tuesday this week, Lenthane Lesoli from BEDCO, stated that in the past ten years of its inception, the initiative has been a cornerstone for their commitment to foster innovation and empowerment, also nurturing talent.

He said the aim is to inject the culture of entrepreneurship within the society, from

Suicide cases a great concern - LMPS

eightened apprehension is palpable within the Lesotho Mounted Police Services (LMPS) regarding the recent surge in suicidal incidents within the country. This concern has been underscored by the LMPS's documentation of five cases of individuals taking their own lives in their weekly reports.

While announcing these reports at the Police Headquarters in Maseru on Tuesday, Police interim spokesperson Superintendent Kabelo Halahala told the media that at Ha Mosebo in the Berea district, a deceased 94-year-old man was found hanging from the roof.

Still in Berea, a 17-year-old boy was found dead after hoisting himself on a tree. While still in the outskirts of the same districts, a 41-year-old man of Ha Ntisa was found dead by his 14-year-old son who noticed him hanged on the roof of their home.

A 33-year-old man of Qeme, Ha Selonyane in Maseru was found hanging on a toilet roof at his workplace at the Lesotho Funeral Services showing no proof of life.

Halahala mentioned that it is not yet clear whether the man claimed his own life or was murdered. He said reports indicate that upon arriving at his workplace from home, the deceased called his family members informing them that he made it to work safely but he was suddenly found dead.

"The death of this man is not yet clear whether he hanged himself or it was somebody who did. Therefore, the police are still doing the investigation on this matter," he said.

A report of another suicidal case was disclosed by the LMPS that a man aged 64 was also found hanging in his bedroom. It was stated that

the man lived alone and therefore, the cause of death is yet to be revealed.

Halahala plead with Basotho to refrain from suicide whenever they go through various predicaments.

"It is our plea to Basotho that they should stop taking their own lives when they are having bad times but they should sit and settle things accordingly without the thought of suicide," he said.

Indigenous knowledge integration in the education system, and communication and information dissemination.

Other important topics discussed was threats face by our country according to shareholders from the education sector was global pandemic, which always brings great impact on them due to the country not being able to prepare for those kinds of disasters in time.

Political instability was another point raised, on this point it was also mentioned that the Ministry of Education is given M2.6 Billion monthly

which M2.1 billion goes to the teacher's salaries so which means the Ministry does not have money at all to improve most of the problems faced in this sector.

Another threat was lack of organization personal serving teachers work force, with the population of 15 000 teachers in the country there are only 4 personnel to assist each and every one of them which is a great impact in the education sector.

These ideas were been carefully noted down, and final decisions will be made at the end of the workshop, which is scheduled to conclude next week.

The workshop has been a platform for constructive dialogue and collaboration, with a strong focus on driving positive change in the education sector

By bringing together professionals from different fields, the workshop aims to create a comprehensive and inclusive strategic framework that will guide education policies and programs in Lesotho for the next five years.

Rapapa showed that as the Ministry they are facing a challenge of unregistered pre-schools, and the education is still not in good conditions. Also he added that there is still a challenge of the teachers who are not well trained.

He added that another big challenge is that money is a problem for them to improve the education, also pre-schools are not free yet primary is free. He showed that parents are hesitant to pay for children to go to pre-school therefore, they skip the level of pre-school.

Rapapa concluded by advising all the schools



to make a celebration of these 200 years and help build the country of Lesotho to a better country.

hursday marked the 50th consecutive day without load shedding being rolled out by South Africa's struggling power utility Es-

Eskom board chairperson Mteto Nyati told broadcaster Newzroom Africa that the power utility is taking it one day at a time.

"First, let's celebrate the 50 days and secondly we are also looking forward as Eskom to another 50 days of (no) load shedding," Nyati said in an interview with the broadcaster.

"But we are taking it one day at a time. We have a generation recovery plan that we have been implementing over the last year and we have another year to go where we can comfortably say load shedding is going to be behind us,"

"We still have another year of working hard, making sure we are safely out of this challenge."

The elongated suspension of load shedding has been widely welcomed by citizens and businesses across South Africa.

However, Electricity Minister Kgosientsho Ramokgopa has often faced a barrage of questions from sections of society who believe the suspension of load shedding is linked to the upcoming May 29 general elections.

Earlier this week, Independent Online reported that Ramokgopa stated that Eskom's En-

of OCTG's, saying it was only being used during morning and evening peaks to meet high electricity demand when it is necessary.

On Thursday, Nyati said South Africa is not Eskom has consistently defended it's use out of the woods yet when it comes to power

"We had a fleet that was highly unreliable. In order for us to say we are safely out of the woods we need to make sure that we touch all of those units and do the proper maintenance," Nyati told the television news channel.

"Right now we have done a sufficient number and that is giving us the reliability that we

On Monday, the power utility said South Africa is currently in a load shedding free environment, not because they are burning diesel to keep the lights on, but because of their extensive maintenance programme and success of their Generation Operational Recovery Plan, which was initiated in March last year.

According to Ramokgopa, who spoke during a media briefing on Monday, the EAF has breached the 70% mark and is currently tracking at 70.78%. This is the first time the EAF has breached 70% since August 2021.

For the month-to-date, the EAF is at 64,34% and vear-to-date (YTD) the EAF has reached 59,92%. - *IOL*

Three decades after Nelson Mandela's historic poll victory formally vanquished apartheid, and less than three weeks before another watershed election, it's all going wrong for the Rainbow Nation. Africa's most developed country is now its most unequal, the World Bank says. Crime is rampant, corruption endemic, growth is tanking. More than 60% live in poverty. Unemployment among black peo-

Voters face a choice on 29 May between a discredited, tarnished ANC, which is predicted to lose its parliamentary majority for the first time, and a broad array of disunited opposition parties. Like 1994, it is also a fundamental choice about what sort of South Africa they democratic or authoritarian, open or

closed, free market or centrally directed, inclusive or exclusive.

The same pivotal choice faces other wouldbe 21st-century powers – countries such as Nigeria, Brazil, Mexico, Iran, Saudi Arabia, Turkey and Indonesia. As when Mandela completed his long walk to freedom, the international community, and the western democracies especially, are watching closely to see which way South Africa jumps. The statistical story so far is an index of broken dreams. Reporting in 2022, the World Bank identified race, apartheid's legacy and unequal land ownership as ongoing core problems. Even now, 30 years on, about 10% of the 60 million population controls 80% of the

Government attempts to level the playing field frequently misfire. Ramaphosa says about 25% of farmland is now owned by black South Africans. But critics argue the land restitution programme has sharply reduced productivity and employment. Government "equity targets" to ensure workplaces accurately reflect the country's racial make-up attract similar con-

The official, overall unemployment figure is a dismaying 32%. Surveys suggest vast disparities between the average monthly incomes of black and white households are persisting. Housing and education are other big problem areas, where the discriminatory and segregationist practices of the past still disadvantage the least well off.

Yet at the same time, white South Africans, angry at the institutionalised bias of the Black Economic Empowerment regulations and spooked by violent crime, continue to vote with their feet. Nearly one-fifth of 1994's total white population has emigrated, exacerbating present-day skills shortages. This has led to arbitrary curbs on capital export and pension payments, and declining tax revenues. Only about 12% of South Africans pay income tax. About 62% of the black population receives state grants (welfare benefits).

In his state of the nation address in February, Ramaphosa implicitly laid much blame for post-1994 failures on his predecessor, Jacob Zuma, who was briefly jailed amid corruption allegations in 2021. "For a decade, individuals at the highest levels of the state conspired with private individuals to take over and re-purpose state-owned companies, law enforcement agencies and other public institutions," he said.

"Billions of rands that were meant to meet the needs of ordinary South Africans were stolen. Confidence in our country was badly eroded. Public institutions were severely weakened. The effects of state capture continue to be felt across society, from the shortage of freight lo comotives to crumbling public services, from the poor performance of our power stations to failed development projects."

It was an extraordinary confession, inadvertently highlighting Ramaphosa's own ineffectiveness since taking office in 2018. Organised corruption remains a hugely destructive problem. The speech provided an odd preface to the coming election, in which Ramaphosa, as ANC leader, is seeking a second presidential

The main challenger is the liberal, centre-right Democratic Alliance, good for an estimated fifth of the vote. Unsustainable state spending, low growth and investment, crime and graft are key DA campaign issues. Yet if the ANC does fall below 50% support, it may be the land-expropriating, hard-left Economic Freedom Fighters and a new populist party, uMkhonto weSizwe (Spear of the Nation), backed by Zuma, that do the most damage.

Messy coalition negotiations could lie ahead. By rights, in any modern democracy, the ANC's record should "cast it into oblivion", wrote Brian Pottinger, former editor of South Africa's Sunday Times. "Not so in South Africa. To many, particularly poor and rural black people, [it] is a powerful, even mystical brand. There is no talgic pride in the ANC's 112-yearlong struggle for black emancipation and dig-

Yet research shows loyalty to the ANC is weaker among post-1994 generations – the socalled "born frees".

Pottinger believes that, while the country desperately needs change, the ANC is incapable of delivering it – and will double down on failure. "The ANC will stick to its catastrophic redistributive economic policies rather than pursuing growth, batten the hatches against capital flight and pre-emptively seek to chill free speech," he predicted.

As western political confidence and business investment wanes, the ANC is relying ever more heavily on defence, security and commercial ties with Russia and China. South Africa has refused to condemn Moscow's invasion of Ukraine and joined naval operations with China and Russia last year. Beijing is South Africa's largest trading partner. Russian oligarchs have helped fund the ANC.

For all who value democracy, freedom and the rule of law, these are plainly the wrong choices. Exploitative great powers and dictators such as Vladimir Putin and Xi Jinping will not save South Africa from itself. Nor will self-serving ANC elites. Only South Africans themselves can do that – by exercising en masse the power of the vote bequeathed to them by Nelson Mandela.

As insurance group rewards top performers at Two Oceans Marathon



"We are still preparing our team for the competition they will participate




in, and we have had training sessions with highly qualified coaches before and we hope to get to that point for the team to have even better practice," he said.

ll roads will lead to Teya-Teya neng this Saturday for the two ∟heavyweights, Lioli and Matlama to excite the local football fraternity as they collide for the Vodacom Premier League title.

The two sides contending for the league have been cut above the rest in the 2023/24 season and hence the title will be decided on the final day. The two teams head to Saturday as favourites to clinch the trophy.

Currently occupying first position, Lioli has managed to surpass expectations this season after the appointment of Motheo Mohapi as Head Coach.
