Basotho ex-mine workers are expressing their frustration over delays and complications in receiving compensation from the Tshiamiso Trust. The Trust, based in the Republic of South Africa, was established to disburse funds to mineworkers who contracted silicosis and tuberculosis (TB) while working in South Africa's gold mining sector. However, the Trust is facing heavy criticism for its poor communication methods, which many claimants believe are obstructing the payment process.

Since the compensation process began in 2019, thousands of Basotho claimants have accused Tshiamiso of either delaying or failing to fulfil its obligations. With the process set to end in 2031, workers are worried that time is fleeting and that they might not receive the compensations they are entitled to.

The Trust was created following a class-action settlement agreement between claimant attorneys and several mining companies, including African Rainbow Minerals, Anglo American South Africa, AngloGold Ashanti, Harmony Gold, Sibanye-Stillwater, and Gold Fields.

To qualify for compensation, mineworkers must meet specific criteria. Current and former mineworkers across Southern Africa with permanent impairment due to silicosis or work-related TB, or their dependents if the workers are deceased, can apply. A mineworker must have performed risk work at one of the qualifying gold mines between March 12, 1965, and December 10, 2019.

Compensation amounts vary based on the severity of the disease. For silicosis, the payments are as follows: Class One pays up to M78,732, Class Two up to M168,712, and Class Three up to M281,187. A special award for claimants in Silicosis Class Three with additional medical conditions pays up to M562,375. Dependent silicosis in Category A pays up to M112,475, while Category B pays up to M78,732.

For TB, compensation is categorized into three degrees: First Degree pays up to M56,237, Second Degree up to M112,475, and Historical Tuberculosis Claimants (those with TB but without a medical report) can receive up to M11,247.

During a recent parliamentary sitting of the Social Cluster Portfolio Committee, Tshiamiso Trust CEO Munyadziwa Kwinda reported that 138,000 workers have lodged claims, with 52,000 of them being Basotho,

representing 38 percent of the overall claimants. Of the roughly 18,000 claimants who have been compensated, 7,918 are Basotho, accounting for 43 percent of all settlements regionally.

"The amount of money paid to Basotho to date is M700 million. When we look at the total amount paid to all claimants in the region, which is around M1.6 billion, 43 percent of that was paid to Basotho," Kwinda stated.

Kwinda also highlighted a major challenge in disbursing funds that many death certificates across the Southern African Development Community (SADC) region do not specify TB or silicosis as the cause of death, which is a requirement for the Trust. Additionally, many claimants become unreachable due to outdated contact information, significantly delaying the process.

"To address these issues, we are extending our services. For example, in Lesotho, we have eight lodgement sites. We had opened another center in Thaba-Tseka to make our

services more accessible, but had to close it due to low uptake. We are also operating mobile units for medical examinations and are now looking at having fixed service providers," Kwinda said.

Tshiamiso's Chief Operating Officer, Tina da Cruz, explained that the Trust's mobilization strategies are based on Section II of the deed. Initially, they used a track-and-trace strategy but have since moved to a pull strategy, encouraging claimants to contact them directly.

"We communicate regularly and have spent over M30 million on communication across the region, informing people about the Trust and the lodgement process. In 2021, we conducted a six-week communication campaign. We also conducted outreach activities in Lesotho, covering eight districts," Da Cruz explained.

Booi Mohapi, representing Justice For Miners (JFM), criticized Tshiamiso for overlooking communication barriers, including language differences and accessibility issues. Although Sesotho is common in both Lesotho and South Africa, it is written differently, creating challenges when updates are sent via mobile messages. Mohapi also noted that many claimants do not have smartphones, making it difficult to access information online.

Basotho Action Party (BNP) leader Machesetsa Mofofmobe echoed these concerns, emphasizing that Lesotho's mountainous terrain makes it difficult to reach some areas, impacting both physical accessibility and telecommunication. He suggested utilizing local government structures and community leaders to improve communication and support for claimants.

"Not all radio stations can reach the entire country. Even if you have a cell phone, calling South Africa is expensive. We need to find cost-effective ways to search for and identify claimants through local government and community networks," Mofofmobe advised.

he Lesotho Mounted Police Services (LMPS) has strongly exhorted the public to refrain from any acts of bribery with the police officers in exchange of snubbing criminal offences. The LMPS warned that, serious measures would follow to anyone found guilty of such.

While presenting the Police Weekly reports at the Police headquarters on Tuesday, LMPS deputy spokesperson, Inspector Mareabetsoe Mokoka warned against this in light of recent reports where four men namely; Natai Mphofe (48), of Ha- Buasono, Berea, Seutloali Thabo (37) of Mount Moorosi, Quthing, Teboho Mahlomola (32) of Matsieng in Maseru and Mosiuoa Phenethi (37) of Ha Jimisi Mazenod , Maseru and Thakeli Ts'elisehsang (37) ,Nketsi Mabote (38) of Maputsoe in Leribe district and Liteboho Mohasoa (32) of Qeme Ha -Mohasoa, in Maseru. These men were accused of road offences and offered bribes in return.

"The court granted them a bail of M500 each and an assurity of M5000. They failed to pay at the time and only Nketsi Mabote

who managed to pay while others were taken to prison. We will recall that one senior deputy Commissioner visited several radio stations to raise awareness of this issue of bribe. It is a serious crime and it has to stop. All those who are known to be participating in these acts shall not succeed from no onwards" she said.

In other reports, a 55 -year-old man named Rets'elisitsoe Nkholise of Quthing appeared before the district's magistrate court on July 11, accused of sexually assaulting a 12-year-old girl. The court found the suspect guilty and was sentenced 10 years in prison without a fine.

In Qacha's Nek, a 60 year-old man named Taunyane Sejono appeared before the district's magistrate court on July 15 accused of possessing an illegal firearm called .38 special and three bullets. Mofoka added that he was apprehended in a search and seize operation for illicit guns on July 13 in the area.

"The court found him guilty and was sentenced to one year in prison or to pay a fine of M2000. He did manage tom pay the fine and was acquitted," she said.

Furthermore , she disclosed that a 31-year-old woman of Berea is facing charges of sexually assaulting a 15-year-old boy .Reports indicate that on July 7, the victim and the woman were commissioned at the suspect's house to get some item but upon to their arrival, the woman then demanded sexual intercourse to the lad.

The young boy defiantly refused and while the matter continued for some time, to her worry, the suspect's mother went to the house to check what could be the hold up. There she discovered that the woman is demanding sex from her son.

"Investigations are still in progress and the suspect will soon appear to the courts of law once everything is finalised." Mofoka said

n a landmark event for Lesotho, the Ministry of Health celebrated the graduation of 49 members from the Advanced Volunteer Health Corps (AVoHC) Surge Response Team.

The ceremony, held in Leribe last Sunday, marked the culmination of an intensive training program aimed at enhancing the nation's emergency preparedness and response capabilities.

In a world increasingly driven by technology, the disparity in internet access is a growing concern. For many in remote areas of Lesotho, connectivity is not just a convenience but a lifeline. Liteboho Letlatsa shares a harrowing tale of how her grandmother's skepticism about charging their phones stems from a tragic event where two young girls were murdered while walking long distances to charge theirs.

In an interview with the Weekly Observer, Letlatsa painted a vivid picture of life with limited access to technology. "Imagine having to wait until dawn just to get a signal for an important call," she said. "It's not only frustrating; it's also a matter of life and death in some cases."

The elderly suffer significantly from poor connectivity. Letlatsa's grandmother has to stand in specific spots in their house to make and receive calls, turning emergencies into desperate situations. For residents of rural areas like Joala-Boholo, unreliable internet is not just a frustration but a hazard. As digital communication becomes ever more integral to modern life, addressing this issue grows increasingly urgent.

This digital divide starkly separates urban from rural areas in Lesotho, prompt-

ing calls for robust efforts to bridge this gap. Ensuring that all citizens, regardless of their location, have access to reliable internet connectivity is becoming a national priority.

Government-owned essential service providers, such as water and electricity companies, enjoy free access to land for their infrastructure. In contrast, telecommunications companies face hefty costs for land access to install their infrastructure. Puleng Mathabo Masoabi, Acting General Manager in the Marketing Communications & Customer Experience department at Econet Telecom Lesotho, confirmed that the company has invested over M300 million (Maloti) in the past three years for the installation of Base

Transceiver Stations (BTS) and system upgrades.

The significant financial burden on telecom companies raises questions about the fairness of the current arrangements with the government. Additionally, vandalism and theft of copper, generators, fuel, fiber power cables, and wooden poles exacerbate connectivity issues. "The overall damage from these acts exceeds 3 million Maloti each year, hindering our efforts to keep Basotho and businesses connected," Masoabi noted.

Mateboho Makote from the Land Administration Authority (LAA) underscored the importance of land planning and allocation for development, as stipulated in the Land Act of 2010. She empha-

sized that private companies, including telecommunications providers, must be involved in this process. However, for BTS installations, land must be claimed, and a lease obtained.

Advocate Nteboheleng Makae highlighted the critical link between internet access and the protection of fundamental human rights, as outlined in the Universal Declaration of Human Rights and the Constitution of Lesotho. She stressed that the lack of internet access in rural areas significantly hinders the realization of these rights, particularly the rights to information, association, and education.

Makae further explained that the uneven distribution of internet connectivity creates an information gap between urban and rural areas, limiting rural communities' ability to stay informed and participate in the socio-political life of the country. This digital divide not only impedes access to information but also restricts freedom of expression. Without reliable internet, rural citizens struggle to participate in public discourse or engage in political activities, leaving their voices unheard and perspectives excluded from mainstream narratives.


Makae's insights suggest that while Lesotho has made strides in safeguarding fundamental human rights, the inequality in internet access presents a significant barrier to ensuring these rights are enjoyed universally. Addressing this issue is crucial for the inclusive development of the nation.



Advocate Lintle Tuke, president of the Law Society of Lesotho (LSL), has called out unethical practices tarnishing the reputation of the country's legal profession. Speaking at the LSL's annual general meeting (AGM) held at Avani Maseru, where he was re-elected unopposed, Tuke addressed pressing issues such as fraud, sexual harassment, and unregistered practitioners posing as lawyers.

In his speech, Tuke lamented the "problematic and unethical behaviour" among some legal practitioners, stating that such actions have severely damaged the profession's image. He highlighted instances of male lawyers defrauding clients and sexually harassing female colleagues, leading to a sense of embarrassment among ethical lawyers.

The LSL president outlined efforts to tighten regulatory measures to restore the profession's integrity. He stressed that all lawyers must register with the LSL and produce valid practicing certificates to clients as proof of their standing. He also condemned senior male lawyers and judicial officers for engaging in sexual harassment and criticized those working unprofessionally from their homes without proper court attire.

The AGM, attended by lawyers from Lesotho, eSwatini, and South Africa, as well as officials from the Legal Practice Council of South Africa and the SADC Lawyers Association, also

saw the presence of Minister of Justice and Law, Richard Ramoeletsi. In his remarks, Ramoeletsi emphasized the importance of making legal services accessible to all citizens and commended the LSL's active participation in recent constitutional reforms.

Ramoeletsi also introduced the new High Court Civil Litigation Rules, 2024, which aim to enhance court efficiency and justice administration. Despite some controversy, he expressed confidence that these rules would improve the legal system with the guidance of experienced professionals

Other key positions within the LSL were confirmed during the AGM, including the uncontested re-election of Advocate Mokhoro Makara as vice-president and Advocate Ithabeleng Phamotse as secretary-general.

The AGM's agenda also included discussions on the challenges and achievements in legal practice and a review of the organization's audited financial statements.

Advocate Tuke's address underscored the urgent need for ethical reform in Lesotho's legal profession, signaling a committed effort to uphold justice and restore public trust.

Parliament may spend up to R14 million for its opening address

arliament has indicated that it has budgeted between R6 million and R14 million that will be used during the opening address set to take place on Thursday at the Cape Town City Hall.

The opening of parliament address takes place once every five years, after the provincial and national elections, to outline the new administration's plans while also marking the official opening of the new five-year term of Parliament.

Speaking during a media briefing on Wednesday, Secretary to Parliament, Xolile George, said they have made that budget because in 2023 during the State of the Nation Address, they had a budget of R8.4 million.

"This is just a budget the actual expenditure may be less or slightly more depending on the reconciliation that we will be doing but this is the amount we have set aside based on the nature and scale," he said.

However, the National Council of Provinces chairperson, Refilwe Mtsweni-Tsipane, said that this budget doesn't include a gala dinner as it has been cancelled due financial constraints.

In June, George said Parliament has almost doubled its budget for the seventh administration and they have set aside R58 million.

"In 2019, we budgeted R43 million for transition, in 2024, we budgeted R58 million. The budgeting is to make transitions for candidates, for flights, accommodation, tools of trade, inductions, and more," he said at the time.

Meanwhile, Speaker of the National Assembly, Thoko Didiza said so far, they are not aware of any members of parliament who plan to boycott the opening of parliament.

Her statement comes after uMkhonto weSizwe Party (MK) snubbed the first sit-

ting of the National Assembly.

MK party members were disgruntled with outcome of the May 29 national elections claiming the results were rigged and insisted on a recounting of ballots. - IOL

He said that the EFF has received monthly donations and a so-called business loan of millions of rands from the bank since 2017 through a front company, Sgameka Projects.

Malema and Shivambu benefited personally, according to Matodzi's allegations

During the briefing, Steenhusien promised to rescue South Africa from radical and anti-constitutional forces.

He was referring to the Economic Freedom Fighters (EFF) and MK Party.

"Where the EFF and MK seek to break our country, the DA seeks to build it. And where the EFF and MK seek to undo the progress made by a free and prosperous South Africa, the DA will fight to advance it," he said.

He continued to say that his party will, through the GNU, demonstrate to South Africans what the DA can do at a national level when allowed to govern.

He further called for unity in the new government arrangement. - IOL

Streaming platform offers diverse local content

esotho's entertainment landscape is undergoing a digital revolution with the launch of novice online movie streaming platform, offering viewers an unprecedented selection of local films and TV

From instant hits to original productions, this new platform is not only captivating audiences but also showcasing the nation's rich storytelling traditions on a global stage.

In a recent interview with the Weekly Observer, Sky Kingdom TV Information Technology Manager Masilonyana Letebele provided insights into the platform's offerings reception and future plans.

The platform is said to boasts a diverse library tailored for Basotho viewers, including popular titles such as Lilaphalapha 4, Makhubelu 4, Chelete Ha se Moleko, Choose Maikhethela, Litsela tsa Khale, Brutal Truth, Ke Reng Uena o Reng, LECSA Shows, Selalome,

Moshanyana oa Sankatana, Nyamatsana,Kau la Phoho, and Petsoa Majoeng.

"This eclectic mix of local productions ensures a rich viewing experience for subscribers," he said.

According to Letebele, upon its launch, the platform witnessed a surge in interest, with up to 5 000 views in the initial days and around 1 200 registrations. However, only about 100 of these registered users converted to paying subscribers and growth has since slowed.

"Despite this, the platform's stability and the ability to produce and launch original TV shows like Choose Maikhethela, Chelete Ha se Moleko and Brutal Truth stand out as early success stories," the Manager noted.

New content was initially added weekly, but recent months have seen a slowdown. Subscription plans are competitively priced, starting at M50 for a monthly subscription, with options for three months, six months and annual subscriptions.

All plans grant access to the entire con-

tent library, although there are currently no free trials or discounts for new subscribers.

"Other thing we can note is the fact that the system is stable and has never disappointed anyone viewers in terms of availability"

The platform recommends an internet speed of 10 Mbps for smooth streaming but does not enforce a minimum speed requirement.

"The platform supports high-resolution streaming and offers adaptive streaming to manage varying internet speeds."

The platform's Co-Founder assured that accessibility is a key feature, with the platform available on web browsers across mobile phones, smart TVs and computers, although a dedicated mobile app is still under development.

"While most content lacks subtitles, producers are encouraged to include them to appeal to international audiences."

Speaking of international reach, the platform has no geographical restrictions,

and has audiences from locations such as London, the United States of America and Australia who also access the content at the same rates as local users.

He went on to add that user experience enhancements like parental controls and multiple profiles are not yet available, but users can log in from up to three devices simultaneously.

Customer support is said accessible via WhatsApp and email, with queries typically resolved within a day. This efficient support system ensures a seamless experience for subscribers.

In terms of exclusive content, the platform has successfully produced shows promoting financial responsibility and romantic relationships, further cementing its role in enriching local entertainment.

"Since the platform is still on its infancy state, we haven't included the adult content which will require parental controls," Letebele concluded.

Moerat was a former SA Schools and Junior Springbok captain, and will now have the honour of being the 66th Bok captain for the one-off Test against the Tier-Two nation.

In all there are seven new caps in the match-23, mostly among the forwards, while the starting backline has a wealth of experience.

Centre Lukhanyo Am is back for his first Test since playing against Argentina in 2023, and forms a potentially exciting combination with André Esterhuizen.

Wing Kurt-Lee Arendse plays again after featuring against Ireland, while Makazole Mapimpi is restored to the left wing with Aphelele Fassi at fullback.

Up front, though, the side is inexperi-

Sharks flank Phepsi Buthelezi will make his debut alongside Ben-Jason Dixon, with his first start, and Evan Roos. in the back row.

RG Snyman partners Moerat in the second row, while Thomas du Toit anchors the scrum at tighthead.

Bulls hooker Johan Grobbelaar is on debut alongside Jan-Hendrik Wessels at loosehad, and on the bench there are potential debuts for hooker Andre-Hugo Venter, lock Ruan Venter, scrumhalf Morné van den Berg and fullback Quan Horn.

"Portugal are a quality team as we saw with their victory against Fiji in the

Rugby World Cup (RWC), while they also drew their clash against Georgia 18-18," said coach Rassie Erasmus.

"It was important for us to select a quality team with a bunch of experienced players, while at the same time delivering on our objective of growing our squad depth by naming a few debutants."

Erasmus said he was pleased to be able to hand the captaincy to Moerat, whose track record as a captain was a testament to his abilities as a fine leader.

"Salmaan commands respect from his teammates, so we'd like to congratulate him on this achievement, and we have no doubt that he'll take on this responsibility as well as he has for the other teams he has led," Ersmus said.

"He has come through the SA Rugby ranks and he went on to captain the Junior Springboks and SA Schools teams, as well as the Stormers and Western Province, which speaks volumes about his quality as a player and a captain."

The match marks the first appearance of the Test season for Rugby World Cup winners Am, Manie Libbok (flyhalf), Cobus Reinach (scrumhalf), Trevor Nyakane and Du Toit (props).

Eight players were members of the match-23 that defeated Wales 41-13 in London in the team's opening match of the season in June: Sacha Feinberg-Mn gomezulu, Fassi, Mapimpi, Esterhuizen, Roos, Dixon, Moerat, and Ntuthuko Mchunu (prop).

"Most of the so-called younger players have been exposed to Test rugby in one way or another by either playing against Wales or Ireland, or have been around



the squad, so they are all well aware of the standards we expect on the field and the way we do things," said Erasmus.

"All of the uncapped players, apart from Ruan Venter, were also members of our training squad in June, and we were very impressed with the way they fitted into our structures and their work ethic. We have full faith in their abilities, and we're excited to see what they offer on the field on Saturday.

"The squad also includes a few RWC winners and experienced campaigners, who will play a vital role in guiding the young players and keeping things calm in the pressure situations."

Erasmus said he expected a fierce battle against Portugal: "They proved that they could compete successfully against some of the top teams in the world, and we believe they will lift their game even more this weekend given the magnitude of facing the Springboks.

"This occasion will really excite them,

and they'll certainly give everything to make a statement for the Tier Two nations, so we have to deliver a top-quality performance to get a result.

"This match is also an opportunity for us to work on what went wrong last week and finish the Castle Lager Incoming Series on a high note, so we will treat them and the occasion with the respect it deserves.

"There are no easy games in Test rugby, and for us personally, it's important to live up to our standards and build momentum going into the Castle Lager Rugby Championship."


